NOFASD Australia is the national peak organisation representing the interests of individuals and families who are living with Fetal Alcohol Spectrum Disorders (FASD). NOFASD Australia is registered as an incorporated association in South Australia under the Associations Incorporation Act 1985 and has held Health Promotion Charity status since 2007. The Organisation has a large network of individuals and organisations interested in FASD and related issues and is working to further develop its membership base.

Since 1999, NOFASD Australia has lobbied to have FASD recognised as a disability in Australia, to advocate for the rights and interests of people living with FASD and to provide information and support to individuals and families at a grassroots level.


What you can expect from us
